

# Canada Housing Trust™ No. 1 completes C\$4.5B public offering

On November 22, 2017, Canada Housing Trust™ No. 1, a special purpose securitization trust, completed a two-tranche debt financing consisting of the issuance of 2.350 per cent Canada Mortgage Bonds™, Series 80, in an aggregate principal amount of \$2,500,000,000, and Floating Rate Canada Mortgage Bonds™, Series 81, in an aggregate principal amount of \$2,000,000,000 for a combined total of \$4,500,000,000 of Canada Mortgage Bonds™, which were provided with Canada's sovereign guarantee through Canada Mortgage and Housing Corporation (CMHC).
