He also maintains an active pro bono practice and was recognized at the 2022 Canada Law Awards for spearheading the "Pro Bono Initiative of the Year" to assist



vulnerable Afghans.

He was previously assistant legal counsel at the Permanent Court of Arbitration in The Hague, where he was the McGill Law fellow and supported arbitral tribunals presiding over international investment arbitrations.
