

# La Loi 5 : un nouveau cadre juridique en matière de protection des renseignements de santé au Québec

La [Loi sur les renseignements de santé et de services sociaux](#) (« Loi 5 ») instaure un nouveau cadre juridique pour la gestion des renseignements de santé et des services sociaux (« renseignements de santé ») au Québec. La Loi 5 reprend plusieurs exigences introduites par la Loi 25 pour les secteurs privé et public. Ses dispositions sont entrées en vigueur le 1<sup>er</sup> juillet 2024, à l'exception de certaines dispositions qui seront applicables ultérieurement
