- Brought a successful Rule 21 motion on behalf of insurance broker defendants confirming pleadings were an abuse of process and barred by res judicata: *National Industries Inc. v. Kirkwood*, 2022 ONSC 937, aff'd 2023 ONCA 63
- Successfully had a claim dismissed against police defendants alleging negligent investigation and defamation: *Supreme Auto Group Inc. v. Chief William Blair*, 2020 ONSC 1223
